Dear Sir/Madam,

The State of Rhode Island passed Article 11 of the 2013 state budget bill enacting R.I.G.L. Chapter 27-57.1 the “Medical Assistance Intercept Act.” The Executive Office of Health and Human Services (EOHHS) promulgated rules and regulations (Policy 0311) to implement this law, which became effective on September 4, 2012. R.I.G.L. Chapter 27-57.1 requires all insurers who do business in Rhode Island to participate in a data match program called the Medical Assistance Intercept System (MAIS). Our records indicate that your company may not be in compliance.

If your company already subscribes to the Information Services Office, Inc. (ISO) *ClaimSearch*, there is no additional cost to participate in the ISO *ClaimSearch* Medicaid Reporting Service and data match with the RI MAIS program. Your company can simply authorize ISO to share the claim data you index by signing a data authorization form. In addition, MAIS provides an interactive “Lookup” feature that is available on the MAIS website after you register. MAIS is designed to fit seamlessly into insurance companies’ procedures and operations. Modeled after the Child Support Lien Network (CSLN), MAIS utilizes the same thorough quality assurance process to ensure a high level of qualified, matched claims.

MAIS is a fully integrated, web-based program that is customizable for all state and insurance users. It will electronically match Rhode Island Medicaid recipients with liability and workers’ compensation insurance claims. Insurance companies and attorneys have the option of doing either a data match through the ISO *ClaimSearch* or utilizing the MAIS interactive lookup system. MAIS is designed to intercept payments of \$500 or more for reimbursement to the State of Rhode Island’s Medicaid Program.
